

**MINUTES
OAKWOOD CITY COUNCIL WORK SESSION
MAY 3, 2010**

The council of the city of Oakwood, Ohio, met in a work session on Monday, May 3, 2010 in the conference room of the Oakwood Municipal Building, 30 Park Avenue. The Mayor of the city, William Duncan, presided. Council members in attendance were Mayor William Duncan, Vice Mayor Steven Byington, Stanley Castleman, Rob Stephens and Anne Hilton; Staff in attendance were City Manager Norbert Klopsch and City Attorney Dalma Grandjean.
